The UK engineering success story that addresses a major environmental challenge

CONICA Ltd in Newark-on-Trent, Nottinghamshire, is at the forefront of the playground safety surfacing and sports surfacing industry and utilises the granules produced by its tyre recycling process as the base, shock absorbing layer in many of its products. The origins of CONICA Ltd go all the way back to 1991 when Charles Lawrence, the pioneer of playground safety surfacing in the UK, decided that his group of companies needed a tyre recycling facility to meet its growing demand for rubber granules.

In January 2014, following acquisition by Serafin GmbH, the company was merged into CONICA AG and changed its name to CONICA Ltd. The facility now recycles end-of-life truck tyres only as they contain a very high percentage of rubber (natural and synthetic), a significant quantity of steel wire and only a very small percentage of fibre. A truck tyre differs significantly from a car tyre which typically contains much less steel and a much higher quantity of fabric. CONICA's focus on truck tyres allows it to produce a much wider range of granule sizes at a much higher quality (free of fabric which is a contaminant) than can be produced when processing car tyres.

The rubber granules produced by CONICA are used in a wide range of applications including CONICA's range of sports, playground safety surfaces and porous SUDS complaint pathways, as well as for moulded rubber products, equestrian arenas and civil engineering solutions.

For over 30 years, CONICA has been at the forefront of the tyre recycling industry. Its world class processes now recover and recycle over 99.5% of the contents of every tyre received, turning waste product into valuable raw materials for other industries. Every year, the Newark facility processes in excess of 400,000 end of life truck tyres and in doing so ensures this waste doesn't go into landfill.

The ending of 'T8 Exemptions' -TRA urges the EA to be ready for the challenge

With legislation soon to be put before Parliament requiring all those operators still handling waste tyres under so-called 'exemptions' to become fully permitted, the TRA has urged the Environment Agency to be ready to meet the challenge.

Writing to EA Chief Executive, Sir James Bevan, the TRA expressed its appreciation at Sir James' stated wish to see this piece of regulatory reform delivered 'at pace', however the TRA went on to voice its concerns are current lengthy lead times to achieve full regulatory compliance. The TRA's letter to Sir James continued:

"Reports suggest that current permit application times are already extended and the expected 'flurry' of last-minute applications will only add to pressures on EA resources. Our fear is that some existing exempt businesses will simply not bother to meaningfully pursue permitted status and attempt to continue operating under the EA's radar".

The TRA urges the Environment Agency to address these concerns before they become realities.

20 Years of Responsible Recycling

More than two decades ago, when the EU's then proposed Landfill Directive was first being mooted, the then newly-formed TRA started to think how it could raise recycling practice standards in Britain's tyre industry.

Perhaps the most important outcome of this early head scratching was the launch of our Responsible Recycler Scheme (RRS) in 2003, an audited better practice regime to which all of our full members subscribe to as a condition of membership. From the very beginning, the RRS has been self-funding with members required to pay for their annual individual compliance audits performed by our independent environmental auditors.
